In Fiscal Year 2017-18 through May 2018, 45 consumers have transitioned from Porterville Developmental Center (PDC) to the community.

In May 2018, 2 consumers from PDC transitioned to the community. In the previous month, Regional Centers (RCs) had projected that 5 consumers from PDC would transition to the community in May 2018. The projected placements that did not occur this month were due to additional transition time provided for two consumers, and a conservatorship process that delayed the transition for another.
